Ellies brand is a Registered Trademark owned by SMD.

The Ellies Fridge Safe and TV Safe products carry a one year manufacturer's warranty from date of purchase, against defective materials and workmanship, and a two year claim warranty from date of purchase, against damage caused by under voltage or over voltage to the equipment that has been used correctly with the Fridge Safe and TV Safe product/s. These products are not designed to withstand a direct lightning strike or loss of neutral, in which case would render this warranty null and void. The Fridge Safe and TV Safe Plugs are excluded from the claim warranty.

The following conditions are applicable to the Fridge Safe or TV Safe products:

1. This Fridge Safe or TV Safe product is for domestic use only, do not use with any other appliance including heavy duty tools or equipment. Any warranty will only apply if the Fridge Safe or TV Safe product/s shows signs of damage from the effects of an under voltage or over voltage whilst performing within its designed capabilities.
2. As a result of an electrical power surge, only the equipment listed (on reverse of this page) will be covered. Therefore identification details such as a serial number of the fridge or TV is essential.
3. The Fridge Safe or TV Safe product must be plugged directly into a properly grounded (earthed) 3-wire AC 16 Amp outlet not exceeding 250 Volt supply. The property in which the Fridge Safe and TV Safe product/s are being used are to be electrically compliant.
4. This warranty will only cover loss and damage occurring as a result of an electrical mains induced under voltage or over voltage and not spontaneous component failure, or other failures not related to electrical surge damage, while using the Fridge Safe or TV Safe products.
5. This warranty is secondary to any existing manufacturer's warranty, implied or expressed, or any service contract in existence at the time of the loss.
6. The manufacturer or authorised agent will inspect the damaged equipment. A report and quotation will be sent to Ellies, who, at its discretion, may request to inspect the damaged equipment and Fridge Safe or TV Safe product, prior to any claims/repairs being authorised.
7. **This warranty will not include any of the following:**
Service charges or service calls.
Routine maintenance.
Installation / Re-installation costs / Set up costs.
Shipping and transport costs.
Any loss and damage by Fire, Theft, Flood, Abuse or Misuse, or any accident.
Any claims for indirect or consequential damage, under no circumstances shall Ellies liability extend beyond the repair or replacement of the affected equipment itself, subject to the limitations referred to here-in.
8. Once Ellies has determined if there is a valid claim for compensation, Ellies will, at its sole discretion, either pay for the repair costs, or compensation. In either case no claim may exceed R20 000.00 (Twenty Thousand Rand) per product warranty.
9. This Ellies warranty is only valid for Fridge Safe or TV Safe products if they are used in South Africa.
10. In the event of a dispute requiring legal proceedings, the claimant accepts the jurisdiction of the Johannesburg Magistrate Court.
11. The sellers of Ellies Fridge Safe or TV Safe products cannot be held liable nor responsible for any warranty claims. No expressions or actions by them shall be binding upon Ellies whatsoever.
12. If any other warranty, either expressed or implied and any changes to the warranty or agreement made in respect of a warranty claim unless in writing and signed by an authorised Ellies employee, shall be invalid.

13. No extension cords, multi-plugs or adaptors may be used in conjunction with any Fridge Safe or TV Safe products, as well as off-grid power generating hardware such as generators and inverters as this will alter the proper functionality and will thus render this warranty null and void, (Fridge Safe or TV Safe must be plugged directly into a wall socket and the Fridge or TV must be plugged directly into the Fridge Safe or TV Safe).
14. If the Fridge Safe or TV Safe product/s have been tampered with in any way, this warranty shall be deemed invalid.
15. **This product carries a two year claim warranty from date of purchase, based on submission and validation of warranty.**
16. **This warranty form must be completed in FULL, scanned and together with a scan or photo of the proof of purchase (entire till slip) and emailed to: customersupport@ellies.co.za Or scan the QR code below to get to the Ellies warranties page. <https://ellies.co.za/warranties/>**



Please remember to submit your completed warranty form within 14 days from the purchase date. Remember to attach a copy of the proof of purchase.

17. Please keep all documents in a safe place as, in the event of a claim, original proof of purchase documents will be required.

CLAIMS PROCEDURE:

1. Claims must be lodged within 7 days of the warranty event.
2. In the event of a claim, register either online at ellies.co.za (the 'Warranty' tab and then the 'submit claim') or email to returns@smdtechnologies.com
3. Complete the online claims questionnaire or the Claims Nomination Form (found at the end of this document) to be email to returns@smdtechnologies.com
4. The claim must be submitted with the following documents:
 - 4.1. the completed warranty form;
 - 4.2. the proof of purchase for the ELLIES HSAP;
 - 4.3. a photo of the ELLIES HSAP product/s;
 - 4.4. the proof of purchase of the appliance;
 - 4.5. a photo of the appliance;
5. The customer is to obtain an inspection report and quotation for the repair of the damaged appliance from the manufacturer or its authorised agent.
6. The inspection report and quotation must be sent to SMD Technologies (Pty) Ltd ("SMD"), who at its discretion may request to perform its own inspection of the damaged appliance/s and ELLIES HSAP product, prior to any claims and/or repairs being authorised. In this event the damaged appliance and the ELLIES HSAP product must be delivered to SMD's returns department or a nominated site for inspection. The customer will be responsible for arranging for collection and delivery and will remain liable for the costs associated therewith.
7. SMD will conduct an inspection to determine the cause of the damage and the course of action and will inform you of the conclusion within 20 working days of receipt of the appliances at its nominated address.
8. After inspection, SMD will either repair or replace, in its sole discretion, the appliance up to a maximum of R20 000.00 per claim.
